The Board is responsible for oversight of the management of the library resources, overseeing the operation of ALL, strategic and business planning, setting policies and procedures for Board governance, approving an annual budget for the operation of ALL, and operating ALL within the funding received.

- · Resource management;
- · Operations oversight;
- Financial and risk management; and
- CEO performance management and succession planning.
