The following positions are available for the 2024-2025 Year:

- First Vice President/President-Elect (three-year term)
- Second Vice President (two-year terms)
- Two Directors (two-year terms)

Commitments:

- Attend regular Board meetings (currently every four to six weeks)
- Participate in establishing LAA's annual goals and objectives and working to see these goals are met
- Serve on committees that carry out the work of the Association
- Promote the Association and its activities to the broader community

Position Descriptions:

• First Vice President / President-Elect

This is a three-year term as the First Vice President becomes the President and then Past President. The First Vice President chairs the Advocacy Committee, co-chairs the Nominations & Elections Committee, assumes the duties of the President in that person's absence, and carries out other duties as may be assigned by the President or the Board. In the second year, as President, presides at all meetings of members and of the Board of Directors and is an ex-officio member of all LAA committees. The President is the official LAA representative and spokesperson. As Past President, responsibilities include ensuring continuity and providing advice on previous Board decisions, co-chairing the Nominations and Elections Committee and other duties as required.

• Second Vice President

This is a two year term. The Second Vice President chairs the Continuing Education committee, and is responsible for the oversight of scholarships, awards and continuing education activities. They also attend all meetings of the Board of Directors and prepares a written report of Continuing Education activities for each Board meeting, as well as an annual report to the Annual General Meeting.

Director

There are three Directors on the LAA Board, two of which are up for nomination in 2024. Each Director is responsible for working on, and often serving as chair of, one of the Association's standing committees (Association Governance, Continuing Education, Advocacy, Intellectual Freedom, and Member Services). Directors also serve on ad hoc committees established by the Board and as representatives to other organizations and LAA interest groups.
